



Kayak and Canoe Rental / Private Boat Launch Rules:

Each person in a rental boat must wear a U.S. Coast Guard approved PFD at all times. Violators may be asked to leave the lake without refund. Repeat violators may be banned from future rentals.

1. Renters must be 18 years of age or older; person under 16 may not operate a kayak or canoe and must be accompanied by an adult over the age of 18 at all times.
2. The posted maximum weight per person and capacities of rental boats must be adhered to.
3. Renter is responsible for observing all posted rules on land and water.
4. Swimming is strictly prohibited.
5. Kayaks and Canoes may not land on or contact the lake bank except at landings specifically provided for such purposes.
6. Boats must remain at least five (5) feet from the lake bank.
7. Boat must be returned on time in order to avoid additional charges
8. Electric trolling motors only; no gas motors of any kind.
9. The use and possession of alcoholic beverages is strictly prohibited.
10. Trash must be placed in designated containers.
11. No person shall operate a boat in such a manner to endanger passengers or other craft.
Recklessness will not be tolerated
12. Fishing from boats will be allowed on any part of the reservoir except in areas designated or restricted. (All NC Wildlife Laws must be followed.)
13. **Kayaks and Canoes are the only vessels allowed on the water.**



Kayak and Canoe Use Waiver and Release of Liability

In consideration of being allowed to participate in Guilford County's kayak and canoe program, the undersigned agrees to the following:

I acknowledge and fully understand that I will be engaging in activities that involve risk of damage to personal property or serious injury, including permanent disability and death and severe social and economic losses which may result not only from my own actions, inactions or negligence, but the actions, inactions or negligence of others, the rules of play, the condition of the premises, or of any equipment used. Further, there may be other risks not known or not reasonably foreseeable at the time.

I assume all the forging risks and accept personal responsibility for all expenses, medical, property or otherwise, following any such damages, injury, permanent disability or death.

I release, waive, discharge and covenant not to sue Guilford County, employees of the organization, other participants, sponsoring agencies, sponsors, a advertisers, and if applicable, owners and leasees of the premises used to conduct the event, all of which are hereinafter referred to collectively as "Guilford County", from any and all liability to me and my heirs for any and all claims, demands, losses or damages on account of injury, including death, or damage to property caused or alleged to be caused in whole or in part by negligence of Guilford County or otherwise.

Guilford County reserves the right to deny admission to use of the lake to any person known to the Park Supervisor and Staff to have violated the rules and regulations pertaining to the use of the Lake and other facilities, or of any person having intoxicating substances in his or her possession or who shows evidence of being under the influence of alcohol or drugs of any kind. Possession of openly displayed or concealed weapons, including handguns is prohibited.

I HAVE READ THE RENTAL RULES AND THE ABOVE WAIVER AND RELEASE, UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND AM ACCEPTING RESPONSIBILITY FOR MYSELF AND/OR MY CHILD. I FURTHER STATE THAT I AM OF SOUND MIND AND THAT I AM VOLUNTARILY SIGNING THIS WAVER.
