Instructions:

Part 1:

- Is to be filled out by the scrap tire generator.
- Shall contain an original signature.
- Only the scrap tire generator shall fill in the information.

Part 2:

- Is to be filled out by the scrap tire hauler.
- Ensure the scrap tire hauler identification number is listed.
- A tire retailer may use its merchant identification number in place of a scrap tire hauler identification number if it solely hauls scrap tires received by it in connection with the retail sale of replacement tires. The tire retailer is then not required to register as a scrap tire hauler.
- Only scrap tires received from the generator, as specified in Part 1, shall be brought for disposal. If usable tires are removed, enter the lower number of scrap tires received.
- Shall contain an original signature.
- Only the scrap tire hauler shall fill in the information.

Part 3:

- Is to be filled out by the scrap tire <u>collector</u>, <u>processor</u>, <u>or disposer</u>.
- Shall be signed or stamped.
- Only the scrap tire collector, processor, or disposer shall fill in the information.
- The scrap tire certification form shall be retained for a minimum of three years.
- A scrap tire certification form is not required for up to five scrap tires brought for disposal by someone other than a scrap tire collector, scrap tire processor, or scrap tire hauler.
- A scrap tire that originates within any county in North Carolina and accompanied by this completed form shall be provided free disposal.
- The fee for disposal of a non-qualifying scrap tire shall not exceed the cost of disposal.
- The county/unit of local government is encouraged to audit scrap tire generators.
- The county/unit of local government is responsible for managing its scrap tire program and the cleanup of scrap tire stockpiles and dumps within its boundaries.
