Carroll Jessup Pkwy, Center Grove Township. Guilford County tax parcel 0136402, totaling approximately 114 acres. Applicant is revising and expanding Phase I and master sketch to add new lots. Zoned RS-30. Surveyor, Hugh Creed Associates

ADVISORY NOTE: Well for Clubhouse must be 100'+ from any septic system or any Private Sewer Line Access and Maintenance Easement (PSLAME).

- 3. Lines 12A must be installed at same time of 16A. 11A, and 13.
