NEW BUSINESS:

MAJOR SUBDIVISION CASE 16-06-GCPL-03142: Pleasant Ridge Road Property UDP

Located on the southeast side of Pleasant Ridge Road approximately 650 feet southwest of the intersection with Stanley Huff Road in Bruce Township. Guilford County Tax Parcels #0145721 & 0145731. This is a Unified Development Plan for the purpose to satisfy watershed built-upon area low density requirements. Zone: RS-40 & AG. (Chuck Truby, CPT Engineering & Surveying, INC.).

Planning Comments: (Dervin Spell, 641-3591)

1) Add note that no further subdivision is to occur without the recording of a new UDP as well as meeting all watershed requirements.

- 2) "16-06-GCPL-03142" at bottom right hand margin.
- 3) Label "City of Greensboro" and "County" along west property boundary.
- 4) Remove address from map title and call it "Pleasant Ridge Road Property".
- 5) Label the Barbara Bowie George property as AG.
- 6) Note North arrow on main plat.
- 7) Indicate linear feet of new streets, area in newly dedicated right-of-way, pavement dimensions.

8) Total r/w width and distance from the centerline.

Watershed Comments: (Justin Gray, 641-5565)

- 1) Provide NPDES Phase II Deed Restrictive Covenant Note.
- 2) Provide Watershed Critical Area (WCA)note under Watershed District Tier 3 & Tier 4.

Jim Lankford motioned for approval; John Nykamp seconded. All members voted unanimously in favor of the motion.
