In order to consider your request for an Identification Badge, we will need you to fill out the attached application form. In addition, we will need a certified criminal records check from each county in which you have resided during the past five years. In Guilford County, these may be obtained from the Clerk of Court in the Greensboro or High Point Courthouses.

Our committee meets monthly to review applications. Your application will be weighed on a number of factors, including the results of background/criminal history checks, need, and frequency of visits. Guilford County reserves the right to refuse any application based on the needs of the county. Any said use of identification badges is subject to being recorded by camera and other means.

If your application is approved, you will be sent a notification which will describe the fees and hours we issue badges. Badges will only be valid during normal business hours, and must be renewed annually.

- ___ I will not loan the badge to another person.
- ___ I will not allow a person without a badge to accompany me through the card swipe entrances.
- ___ I will not carry unauthorized items into the courthouse. I understand security inspections may be conducted as necessary.
- ___ I must contact Security promptly at 641-7695, Room LG-17, Guilford County Courthouse, Greensboro if the badge becomes lost or stolen. I understand the badge must be protected from sun, moisture, and magnetic fields.
- ___ Having an ID badge is a privilege. This privilege can be rescinded by proper authority in their sound discretion.
- ___ All badges are the property of Guilford County and must be surrendered upon request of proper authority.
- ___ Badges must be renewed annually. A renewal fee, current criminal record check and favorable review will be required.
- ___ Badges must be displayed at all times while in the courthouses.
- ___ If I forget the badge or allow it to expire, the public entrances must be used.
- ___ I will promptly turn the badge in to GC Security if I change employers or businesses.
- ___ Frequency of visits are subject to verification. Infrequent use or losses can result in revocation or higher fees for renewal.
- ___ This ID is to be used for company courthouse business only and is not for personal use.
