MINUTES:

The minutes of the April 17, 2018 meeting were approved as submitted.

Minor Subdivision Case 18-04-GCPL-02033: Robert Fryar. Located approximately 1,900 northeast of the intersection of McLeansville Road and Burlington Road in Jefferson Township, Guilford County Tax Parcel 0119257. The applicant is proposing one special purpose lot for a septic lot. Zoned: AG (Hugh Creed Associates, Inc.).

Planning Comments: (Paul Lowe, 641-2489)

- 1. Phone number for owner, if any.
- 2. The proposed private sewer access easement crosses the stream.

Erosion Control: (Earl Davis, 641-3803)

- 1. Obtain a grading permit from Guilford County if total land disturbance is one acre or more, and if the property use is not related to mining operation.
- 2. Coordinate with NCDENR if one acre or more, and is related to mining op.

Watershed Comments: (Frank Park, 641-3753)

1. There is a 20 feet private sewer line access and maintenance easement crossing the stream. The activity is "allowable" not "exempt". Therefore, it is allowable, meaning they need written permission from Teresa and she has to follow up with site visits. Contact Teresa Andrews, Storm Water Administrator at 336-641-5565.

Environmental Health Comments: (John Nykamp, 641-4807)

- 1. Off-site septic system must comply with 15A NCAC 18A .1900 "SEWAGE TREATMENT AND DISPOSAL SYSTEMS".
- 2. Existing property line should be removed from Special Purpose Lot.
- 3. Show 20' Utility Easement.
