#### Agenda

## District Conservation Programs – Millie Langley

- Millie presented the NC Ag Cost Share Report. (attached) There were two AgWRAP Contracts presented for approval which included: 41-2016-801, Livestock Well, \$5,710 and 41-2016-802, Irrigation Well, \$5,709. Dick moved to approve the AgWRAP Contracts and Harold seconded. The motion carried.
- There was some discussion about active contracts as well as expiration dates and the need to send reminder letters to landowners.
- Millie said that the county has \$504 in budget that can be used for needed repairs to the No-Till Drill.

## NRCS Report – Kelley Smith

The Conservation Stewardship Program is a 5 yr. term incentive based program. Application deadline
has been extended to March 31<sup>st</sup>.

# County Comments - Leslie Bell

- Leslie reported that the commissioners did not disband the Environmental Review Board.
- The Budget for 2017 was wrapped up on Monday and that it includes a new full-time Forestry position.

### <u>District Operations – Elizabeth/Millie</u>

- Monthly Expenditure Report was reviewed by the supervisors.
- The Ag. Foundation Scholarship Reception will be on March 20<sup>th</sup>. Each year, the Ag. Foundation gives about \$500 scholarship to a NC State University student through Guilford SWCD's Endowment.
- Elizabeth gave a report on the results of the Tree Sale Fundraiser (attached). There was discussion about future fundraising. Publicity seems to be key. Millie and Jamey will research the Geotextiles and Coco Matting as a possible fundraising opportunity.
- Elizabeth gave a report on the results of the Contests. There were 14 Essays and 48 Posters.
- Millie reported about her experience with the Supervisor Training.
