The Board Meeting was called to order by Chairman, George Teague, at 9:00 a.m. He read the Conflict of Interest Statement and asked if there were any conflicts of interest. None were noted.

Agenda

Lewis Brandon moved to approve the agenda. Harold Alexander seconded. The motion carried.

Minutes

Harold moved to approve the March 2, 2016 minutes as presented. Lewis seconded. Motion carried.

<u>District Conservation Programs – Millie Langley/Jamey Walker</u>

- Jamey presented the NC Ag Cost Share Report. (attached) There were ten NCACSP RFP presented for approval which included: 41-2015-008, FB, \$1,069; 41-2016-005, Stream Protection, \$8,397; 41-2016-006, Cover Crops, \$605; 41-2016-007, CC, \$312; 41-2016-008, CC, \$464; 41-2016-009, CC, \$1,544; 41-2016-010, CC, \$388; 41-2016-011, CC, \$412; 41-2016-012, CC, \$1,356; and 41-2016-013, CC, \$1,230. Lewis moved to approve the NCACSP RFP and Harold seconded. The motion carried.
- There was one AgWRAP Contract presented for approval: 41-2016-801, Livestock/Irrigation Well, \$5,710. Harold moved to accept the AgWRAP contract. Lewis seconded and the motion carried.
- There was one CCAP RFP: 41-2016-501, Abandoned Well Closure, \$1,125. Ray Briggs moved to approved the CCAP RFP and Lewis seconded. The motion carried.
- Jamey and Stephen Dew have been working on an inventory of the VAD signs in the county. A lot
 of signs are stolen or leaning. Leslie will work with the facilities director to determine a method of
 installation that will reduce theft and leaning.
- Millie will order the GPS unit for \$8,014.79 using grant funds and county matching funds which have already been budgeted in to the Software, Service and Maintenance line item.
- Millie presented the 2016 Strategy Plan for supervisors to review before the next board meeting.
 Supervisors will make 2017 Strategy Plan at the April Board Meeting.

County Comments – Leslie Bell

- Leslie reported that Elizabeth's position was initially approved to become 30 hr./week starting July 1st.
- He also reported that Karen Neill would be Jamey's back-up person regarding the management of the VAD signs and program.

<u>District Operations – Elizabeth/Millie</u>

- Monthly Expenditure Report was reviewed by the supervisors.
- Elizabeth reported that the Annual Dues for the NC Assoc. of Soil & Water Districts has risen to \$975 due to changes in population in Guilford County. She requested that money be moved from

- the Transportation/Travel line item to Dues/Membership to cover the cost of the dues. Lewis moved to approve request and Dick Phillips seconded. The motion carried.
- Millie requested that the Guilford District fund the registration costs for the two Envirothon Teams at a cost of \$220. It was suggested that the funds come from Printing/Office supplies and that we should budget for two teams every year. Lewis moved to approve request and Dick Phillips seconded. The motion carried.
- Millie reported about the need for more volunteers at the State Envirothon and thanked Harold for signing up.
- Elizabeth reported that the applications for RCW will be due May 2nd and supervisors will vote on a student at the May meeting.
