**\*Qualifications To Hold Office:**


- \*Registered Voter
- \*Twenty-one (21) years of age; NC Const. Art.VI, Sec.6 (Exceptions – 25 years of age – State Senate; NC Const. Art II, Sec.6)
- \*Age limit for service as justice or judge; may not continue in office beyond the last day of the month in which they attain their 72<sup>nd</sup> birthday (G.S. 7A-4.20)
- \* Affiliated with a political party for 90 days by the date of filing Notice of Candidacy
- \*Residency Requirement: U.S. Congress – NC Resident by date of general election, residence not required in district; State Senate – 2 years in State, 1 year in district (NC Const. Art II, Sec. 6); State House – 1 year in district (NC Const. Art II, Sec. 7); County Commissioners, Superior & District Court Judges must reside in the district; Register of Deeds & Soil and Water Conservation Dist. Sup. must reside in Guilford County, Archdale Mayor and City Council must reside in municipality and/or ward.
- \*Superior Court Judges & District Court Judges must be authorized to practice law in North Carolina court (NC Const. Art IV, Sec. 22)
- \*Citizenship Requirement: U.S. Congress – U.S. Citizen for a least 7 years

\*\*The filing fee is calculated by one percent of the annual starting salary of the office. Municipal fees are determined by the municipality with \$5 being the minimum amount.

\*\*Deadline for all December candidates to withdraw Notice of Candidacy – December 12, 2023

\*\*Deadline for Soil and Water candidates to withdraw Notice of Candidacy – July 2, 2024

\*\*Deadline for Archdale Mayor and Town Council candidates to withdraw Notice of Candidacy – July 16, 2024
