FY 2019 Meeting Number 7; February 6, 2019 Minutes

## NRCS

- Angela Little is no longer the Assistant State Conservationist for Field Operations in Area 2. Mark Ferguson
  will be acting for the time being. Information on when positions will be filled is not currently known.
- Most of the deadlines for NRCS Programs have been delayed due to the government shutdown.

- The Monthly Expenditure Report contained no expenses. We have received \$568.00 in pre-orders for the
  District's Annual Tree Seedling Sale (February 11-15 8AM-6PM). The fundraiser is officially profiting from
  sales.

  held Thursday, May 23, 2019. The banquet will be held in conjunction with the VAD, similar to last year. A
  time for the event will be determined at the next board meeting, after contest winners are announced.
