The site plan application is to use approximately 1.44 acres out of a 41-acre parcel (owned by John Ward) for a temporary construction laydown yard for a utility construction project. - 3. Obtain a county floodplain development permit.
- 4. The county flood prevention ordinance does not allow any fills to be stockpiled and compacted at the SFHA nor floodway.
- 5. Obtain a steam buffer authorization from Teresa Andrews, Stormwater Administrator.
