Trips must be scheduled in advance, no later than noon the working day before your trip.

How about a ride to work?

Are you tired of dealing with traffic?

Financially burdened by the high cost of gas?

Need assistance with transportation to work so that you can keep your job?

Guilford County Transportation and Mobility Services has a solution for you – our **Employment Transportation Mobility Program**. Employment transportation is provided 7 days a week, 24-hours a day. To receive service, each passenger must complete an eligibility form. Destinations for employment transportation assistance include job fairs, job readiness or training activities, workplace and job interviews.

Anyone can ride...

Any Guilford County resident may use the service if either your origin or destination is located outside the city limits of Greensboro or High Point or if your work schedule is outside the operational hours of GTA or Hi tran. There is a one-way fare of \$2.50 for each passenger. Children of a working parent or legal guardian can be transported to child care as part of the employment trip.

Keep your independence...

Persons over 60 years of age or persons that have a physical or mental disability can receive employment transportation. You may receive a ride on the system or fuel reimbursement for you or someone that drives you. There is a one-way fare of \$2.50 if you ride the system. Persons over 60 years of age ride for free of charge. Funding for this service does not allow for transportation of children to child care.

Do not let a lack of transportation keep you from working...

The Employment Transportation Assistance program, funded by NCDOT, provides employment transportation to former **Work First recipients and participants in workforce development programs**. Children of a working parent or legal guardian can be transported to child care as part of the employment trip. The program allows for a ride on the system, bus tickets, fuel reimbursement, car repairs or assistance with car insurance. Former Work First recipients must have a referral from the Department of Social Services. Workforce Development Program participants must show proof of participation in one of the following certified programs: Job Links, Vocational Rehabilitation, Goodwill, Employment Security Commission and Women's Resource Center – New Choices.

Guilford County's public transit system is a shared ride service. Our primary service is to persons in need of transportation to medical appointments and senior centers. Our fleet consists of sedans, vans and mini-buses. We have lift-equipped vehicles to accommodate riders in wheelchairs.

Guilford County Transportation and Mobility Services Title VI Policy Statement
