## MAJOR SITE PLAN CASE #19-11-STCP-08975: BiRite Stokesdale (Food Store).

The property is located on the northeast corner of Belews Creek Road and Ellisboro Road, Guilford County Tax Parcel #162100. This is a site plan for a BiRite Grocery Store. #### MAJOR SUBDIVISION CASE #19-12-GCPL-08301: Rogers Farm Subdivision Master Sketch Plan.
