2. 2022-352 BUDGET SECOND TRANCHE OF AMERICAN RESCUE PLAN ACT

(ARPA) CORONAVIRUS STATE AND LOCAL FISCAL RECOVERY

FUNDS (CSLFRF)

Background: Guilford County has received the second tranche in the amount of

\$52,169,876 of Local Fiscal Recovery Funds from the American Rescue Plan legislation on June 9, 2022. The total allocation and amount received to date is \$104,339,752. These funds may be used to support public health response, replace public sector revenue loss, address negative economic impacts, invest in water/sewer and broadband infrastructure and provide premium pay for essential workers. It is critical to the long-term success of our community and in alignment with all best practice recommendations that we (1) take great care in the oversight and administration of this funding and (2) carefully evaluate and plan for transformational one-time investments in our county that build a more resilient and equitable ecosystem of

support for our residents. All funds must be appropriated by December 31, 2024 and expended by December 31, 2026.

HEALTH SCIENCES ANTIMICROBIAL-RESISTANT GONORRHEA

CONTRACT - \$383,845

Background: Through funding from NC Department of Health & Human Services

- Epidemiology/Communicable Disease Branch, Guilford County Department of Health & Human Services - Public Health Division has a health trends research contract with Wake Forest University

Health Sciences. Wake and Guilford are jointly researching

drug-resistant gonorrhea. Wake Forest will collaborate with Public Health to explore mechanisms to increase Guilford PH lab capacity as we pilot new methods of gonorrhea resistance testing and

as we phot new methods of gonormea resistance testing

developing novel strategies for rapid response to antimicrobial-resistant gonorrhea.

This contract amount is \$383,845. The effective period of this contract is June 1, 2022 to May 31, 2023. This is the seventh-year of funding and results so far have been promising.

INTERLOCAL AGREEMENT BETWEEN DHHS-PUBLIC HEALTH DIVISION AND ALAMANCE COUNTY DEPARTMENT OF PUBLIC HEALTH - \$11,643

Background:

Guilford County Division of Public Health (GCDPH) participates in a grant called the Minority Diabetes Prevention Program (MDPP) through the NC Office of Minority Health and Health Disparities. The Alamance County Health Department is the lead county that administers grant funds to nine counties which includes Guilford, Chatham, Rockingham, Durham, Alamance, Orange, Caswell, Person, and Randolph counties. MDPP is a CDC, evidence-based pre-diabetes program designed to be administered over the course of one year to qualified participants. The goal of MDPP is to increase access to diabetes prevention programs for minorities to delay the onset of full-blown diabetes or prevent its onset. In conjunction with community partners, GCDPH is finishing up its fourth year of MDPP classes and entering the sixth fiscal year of the MDPP grant. For the last year, the COVID-19 pandemic has presented challenges to administering MDPP. As an evidence-based program, the best practice is to conduct classes in-person with other participants so that group support can be developed with engagement from the lifestyle coach who conducts the classes. For this last year, classes had to be cancelled since in-person activities could not be held due to COVID-19. One class was held using an online platform. Despite these challenges this class which was based out of Mount Zion Baptist Church did have success.

As of June 2022:

Participants: 11

81.8% of participants met physical activity goal of 150 minutes per week

Mean overall weight loss change: -10.7lbs; mean overall percent change: -5.44%

Through this interlocal agreement with Alamance County Public Health Department, Guilford County Public Health has been awarded funds in the amount of \$11,643, which are included in the FY22-23 adopted budget, to assist in carrying out the following activities: screening, educational programs and active living classes. The contract is effective 6/1/2022 for a term of one (1) year.

Background:

AMEND MEMORANDUM OF UNDERSTANDING BETWEEN GUILFORD COUNTY AND CITY OF GREENSBORO FOR TRANSFER OF ERA FUNDS - TRANSFER OF APPLICATIONS & REDUCTION IN AMOUNT Guilford County entered into a Memorandum of Understanding with the City of Greensboro in October 2021, which was amended in March 2022, to allow up to \$10 million in ERA 1 and 2 funding (\$5 million from each program) to be transferred to the City for payment of outstanding City ERA applications with ERA 1 and ERA 2. The MOU provided an initial \$2 million "initial allocation" to be paid in advance with the remaining \$8 million to be paid out on a monthly reimbursement basis in amounts not to exceed \$2 million per payment. As of July 7, 2022, the County has made the initial \$2 million payment plus one reimbursement payment in the amount of \$1 million for a total of \$3 million paid out and \$7 million remaining on the contract.

In late June 2022, the City submitted a request to the County for the City to transfer 332 applications to the County for processing. For all of these "transfer cases", the applicants have all started the review process but are pending additional information necessary for final approval. The City has also agreed to a reduction in the contract amount to the value of payments made plus the estimated value of remaining cases that they will process.

The City has 596 applications that they will not transfer to the County and continue to process themselves; these have an estimated value of \$3.5 million based on the average payment amount per City application. Adding the initial \$3 million in payments made, the total anticipated cost for City applications under this MOU will be \$6.5 million. Staff recommend that the total amount of the MOU be reduced by \$3.5 million with the reduction made in ERA 2 funds allocated to the City since these funds have a longer deadline for spending than ERA 1 funds which will allow the County more flexibility in utilizing these funds for rental assistance including through its eviction mediation program. Updated funding amounts by program will be \$5 million in ERA 1 funds (spending deadline of September 2022) and \$1.5 million in ERA 2 funds (deadline of September 2025).

DHHS staff recommend that the MOU with the City be revised to 1) reduce the total transfer amount to \$6.5 million from \$10.0 million to reflect prior payments plus "in progress" applications retained by the City; and 2) add any necessary clarifying language to reflect that the City will process only applications that were in progress as of July 5, 2022 and not transferred to the County.

Background:

Additionally, as part of the FY2023 budget process, non-profit agency funding was removed from the adopted budget to ensure compliance with Session Law 2021-191 (S.B. 473). This law modifies governing board members' duty to vote and recusal procedures. Specifically, Section 14-234.3 prohibits public officials who also serve as directors, officers or governing board members for non-profit organizations from participating in, making or administering and contracts with those non-profits. When a governing board considers a contract with a non-profit organization, including the award of any funding, board members involved with that non-profit must recuse themselves from any deliberation and record their recusal with the Clerk to Board.

## **B.** 2022-366

BUDGET AMENDMENT & AUTHORIZATION OF THREE (3) NEW POSITIONS: DHHS-PUBLIC HEALTH DIVISION EVIDENCE-BASED STRATEGIES FOR MATERNAL AND CHILD HEALTH - \$475,000

#### Background:

The North Carolina Division of Public Health awarded Guilford County Department of Public Health \$475,000 to implement evidence-based strategies that are proven to lower infant mortality rates, improve birth outcomes, and improve the overall health status of children ages birth to five.

In 2019, the state's overall infant mortality rate was 6.8 deaths per 1,000 live births, with no change in the rate from the 2019 rate of 6.8 deaths per 1,000 live births. Significant racial disparities remain. The multi-factorial, comprehensive, population-level maternal and child health initiative addresses three aims: (1) improve birth outcomes, (2) reduce infant mortality, and (3) improve the health status of children ages 0-5.

The following long-term (3-5 years) outcomes will measure the achievement of the three aims for all racial and ethnic groups.

- · The rate of infant mortality
- · The rate of unintended pregnancy
- · Birth spacing rates
- · Preterm birth rates (babies born < 37 weeks)
- Low (<2500 grams) and very (<1500 grams) birthweight rates
- The rate of child death, among children ages 1-5
- · The rate of substantiated child abuse and neglect cases
- The rate of out-of-home placements for children ages 0-5

At this time three local health departments have been awarded funding to act as lead health departments to implement Improving Community Outcomes for Maternal and Child Health (ICO4MCH) and Evidenced-Based Strategies. The lead health departments are Guilford County Department of Health and Human Services - Division of Public Health, Mecklenburg County Health Department, and Wake County Health & Human Services.

## **Scale of Service Levels**

Funding from this award will allow the department to focus on infant mortality by implementing selected Evidence- Based Strategies using a collective impact framework, the principles of Implementation Science, and a health equity approach by hiring 3 additional community health educators. For each Aim of the project,

evidence-based program(s) were selected to be implemented during a two-year timeframe.

## **Aim 1: Improve Birth Outcomes**

Evidence-Based Strategy: Improving Preconception and

Interconception Health

## **Overview of Activities:**

Implement evidence-based grassroots education strategies through Community Health Worker, Health Ambassador and Peer Education models to disseminate preconception and interconception health information to high impact areas of Guilford County. Implement Mothers and Babies curriculum, an evidence-based intervention to assist pregnant people and new parents to manage stress and prevent postpartum depression.

## Aim 2: Reduce infant mortality

**Evidence-Based Strategy:** 10 Successful Steps for Breastfeeding **Overview of Activities:** 

Implement evidence-based breastfeeding promotion strategies to increase the breastfeeding continuation rate of Black birthing people in Guilford County. Increase the number of businesses to become certified Breastfeeding Friendly Workplace environments.

## Aim 3 Improve the health status of children ages 0-5 -

**Evidence-Based Strategy:** Positive Parenting Program (Triple P) **Overview of Activities:** 

Expand implementation of the Positive Parenting Program (Triple P) to pediatric practices through Children's Home Society of NC's Healthy Steps Specialists. Triple P is an evidence-based program to reduce problem behavior in children and improve parents' wellbeing and parenting skills.

Staff recommend accepting the award, approving the budget amendment, and authorizing three (3) new positions, which are 100% funded by the award.

#### DHHS-DSS MANDATED PERFORMANCE MEASURES

Guilford County signed an annual written agreement with the North Carolina Department of Health and Human Services for all social services programs, excluding medical assistance (Medicaid). This agreement required Social Services to comply with meeting certain performance and growth measures.

This presentation will be provided monthly to keep Guilford County's Board of County Commissioners informed of Guilford's progress. The attached results represent data for the month of May 2022.

Background:

Budget and Management Services prepares Budget Performance Reports as part of our monthly budget monitoring work. These reports are intended to show the current status of the county's actual expenditures and revenues compared to budgeted amounts and to identify areas of concern that may require additional staff and/or board action. At this time, staff are monitoring year-end performance to determine the County's net position (adding or using fund balance). Important remaining factors include:

- o How the final three months of sales tax actuals perform.
- o Staff are monitoring intergovernmental revenues as June is generally the largest month.
- o Increases in the Federal Reserve interest rates may impact mark-to-market adjustments required by GASB standards.
