

## **Dog-to-Dog Introductions Waiver**

Guilford County Animal Services strives to provide a safe and secure place for our community and the animals under our care.

Although animals are supervised, injuries can still occur while dogs are interacting with one another. Such injuries are not common, but the risk is there, especially with dogs with little known history of behavior and/or medical conditions. In addition, while infrequent, dogs can get into fights, even under close supervision.

It can be difficult to predict how your dog's behavior might change when brought into an unknown environment, especially when the environment is an animal shelter full of new sights and scents. It is therefore also important for you to recognize that the behavior(s) your own dog exhibits during a dog-to-dog interaction may be different from what you expect or what you have seen previously. This could include signs of fear, anxiety, and/or aggression, to name a few.

Guilford County Animal Services has procedures in place to screen dogs for aggressive behavior. However, this is not a guarantee that a dog will not be aggressive towards your dog. Even the friendliest of dogs can get into fights with very little or no warning. In addition to injuries, it is possible for dogs to transfer illnesses, even with the required vaccinations and boosters. Such illnesses do not occur often and all dogs must have the necessary vaccinations to be allowed to participate in a Dog-to-Dog Introduction.

Please keep in mind that even if the introduction is positive at the shelter, this does not indicate or guarantee it will be the same in the home environment. The home is your dog's territory and there may be unforeseen issues with the dogs acclimating together there.

By allowing your dog to participate in a Dog-to-Dog Introduction, you acknowledge these rules and agree as follows: (please initial)

I represent that my pet is up to date on all required vaccinations including but not limited to Rabies, Distemper and Bordetella (kennel cough).

I understand that staff may, in staff's own discretion, may determine that any dog-to-dog introduction is inappropriate under the circumstances and decline to conduct the introduction.

I agree that Guilford County Animal Services will not be liable for any claims of injury, illness, damage or death to my dog during the introduction, including but not limited to any claims for consequential damages, emotional distress or physical injury.

I agree that Guilford County Animal Services will not be liable for any claims of injury, illness, damage or death to me and/or any family member during the introduction, including but not limited to any claims for consequential damages, emotional distress or physical injury.
